3. ELIGIBILITY:

3.1 EDUCATIONAL QUALIFICATIONS(GENERAL):

3.1.1 Regarding Universities/Institutions of outside State, the candidates shall only be eligible for appointment after verification of genuineness of their educational/training qualification from concerned University/Institutions from which they have obtained the degree. Candidates from such outside University/Institutions shall have to produce the authenticated proof of equivalency from any University of the State of Odisha and NCTE recognition in support of their qualification at the time of document verification, failing which they will not be eligible in the selection process.

3.1.2 A candidate furnishing certificates, mark-sheets with grades and grade points shall also furnish numerical equivalency of grades/grade points from the examining bodies.

3.1.3 Candidates must specifically indicate the percentage of marks obtained(calculated to the nearest two decimals) in the relevant columns fo the application. Where percentage of marks is not awarded by the University but only CGPA/OGPASGPA is awarded, the same shall be converted into percentage in terms of conversion norms of University, besides indicating the CGPA/OGPA/SGPA in the application. Candidates will have to produce the certificate/document issued by the University in support of conversion formula of University and percentage of marks, when called for document verification.

3.1.4. Round off of %age of marks will not be acceptable under any circumstances for consideration for appointment i.e. 49.99% will be treated as less than 50%, like wise 44.99% will be treated as less than 45%.

3.1.5. The date of declaration of result/issuance of Mark Sheet shall be deemed to be the date of acquiring the qualification and there shall be no relaxation in this account.

3.1.6. The knowledge of computer application is desirable for all the posts except the post of Drivers and Gardeners.

3.1.7. The candidates not having the prescribed academic/professional qualifications, experience and not qualified CTET/OTET/OSSTET/TET as applicable for the respective posts need not apply. DAV Regional Directorate will not be held responsible if the candidature of such candidate is cancelled at any stage of the recruitment process.

3. **PGT (Computer Science):** Master degree in Computer Science/M. Tech / MCA with minimum 50% marks from any recognized University and B.Ed. degree from a NCTE recognized University.

N.B. : Good command over spoken English and knowledge of computer application is essential.

Note:#(i) M.Sc Degree in Bio-Chemistry from a recognized University after doing a minimum of 6 years study after matriculation (For Chemistry teachers only). Post-Graduation in Pharma-Chemistry or other disciplines related to Chemistry be treated at par with M.Sc. Chemistry provided it is preceded by Graduation in Chemistry.

(ii) Post Graduation in Statistics or Operational research be treated at par with M.A/M.Sc. Mathematics provided it is preceded by Graduation in Mathematics.

(iii) Post Graduation in Micro Biology or Molecular Biology or Agricultural Botany or Genetics or other related disciplines be treated at par with M.Sc. Botany/Zoology provided it is preceded by Graduation in Botany /Zoology.

3. Music Teacher: Graduate/Post Graduate in/with Music(vocal) from a recognized University with at least 50% marks.

Certificate verification of the shortlisted candidates will be made at 8.30 A.M. on the day of personal interviews. After certificate verification, all the shortlisted candidates shall have to appear the Computer Skill Test (Preparation of Word Document i.e. question in respective subjects, sending email, preparation of spreadsheet, preparation of PPT etc.). During certificate verification, if any candidate is found not satisfying the eligibility criteria, he/she shall not be allowed to appear the Computer Skill Test & Personal Interview.

3. **AGE LIMIT AS ON 01.05.2023:**

The **Maximum age** limit for the post of Teachers (PGT/TGT/PRT/PPT), Counsellor, Yoga Teacher, Music Teacher, Dance Teacher, Art & Craft Teacher, Librarian, Hostel Warden and Driver as on 1st May, 2023 shall be **40 Years** and for all other posts it shall be **32 Years**. Age relaxation may be considered in case of experienced/deserving candidates for the Post Graduate Teachers in absence of suitable candidates within the age bar.

The **Minimum age** for all the posts is 21 years as on 01.05.2023.

4. Separate application should be submitted for separate posts. The DAV Regional Directorate will not be held responsible, if the CBT/interview schedule of any candidate for multiple applications/posts coincides.

5. **SELECTION PROCEDURE:**

5.1 A merit list shall be prepared to invite the candidates for each post/subject for interview on the basis of **marks secured in the Computer Based Test**.

5.2 In cases where more than one applicant secures equal aggregate marks at any stage of examination, tie will be resolved by applying the following methods one after another:

- A) Total marks in Part-III i.e. Subject Content
- B) Career Marks
- C) Date of birth, with older candidates placed higher

5.3 Candidates for teaching post will be selected on the basis of their performance in Computer Based Test(CBT), Interview and Career marking put together. All the candidates for teaching posts shall have to qualify in the computer skill test and no marks shall be awarded for the computer skill test.

- 5.4 Candidates for non-teaching post will be selected on the basis of their performance in Computer Based Test(CBT), Interview, Career marking and computer skill test put together.
- 5.5 **The DAV Regional Directorate reserves the right to decide the cut off marks in CBT and interview separately and the criteria for short listing.**
- 5.6 The mode of selection for all the above posts will be at the sole discretion of DAV Regional Directorate.
- 5.7 The decision of the DAV Regional Directorate with regard to the mode of selection of the above posts and eligibility conditions of the applicants for the interview shall be final and binding. No correspondence will be entertained in this regard.
- 5.8 The Online Question Paper (MCQ) will be in English only. However, the question papers in languages viz. Odia, Hindi & Sanskrit will be in the respective language.
- 5.9 The candidates will be required to report at the examination centre at least 1½ hours (90 minutes) before the commencement of the online examination. Candidates coming late for the test will not be allowed.
- 5.10 Time schedule may change depending upon number of applications received for a particular post and subject.
- 5.11 Candidates who will qualify in the CBT and shortlisted for interview must submit the true copies of documents duly self-certified. The candidates are required to mention on each document "submitted by me" and put their full signature & date on the same. Only those who are called for the interview will be required to bring with them the Original Certificates on the day of verification as communicated through e-mail. If a candidate fails to furnish any original certificates and documents in respect of his/her qualification/experience will not be entertained for the interview.

- 6.2 However, the number of centers will increase or decrease depending on the number of applications. Applicants should clearly indicate their order of preference for any Three "**Examination Centers**", for online test according to their preferred option of the city in the online application format.
- 6.3 No request for change of test centre once allotted will be entertained and the candidate will have to appear at the allotted centre at his/her own expenses only.
- 6.4 Examination authority/agency reserves the right to conduct the CBT at all the cities or in one or more than one cities depending upon the number of candidates opting for a City and also based on the availability of test centres and computer nodes.
- 6.5 **The personal interview of the shortlisted candidates will be conducted in Bhubaneswar only.**

7. **IMPORTANT INFORMATION AND INSTRUCTIONS:**

7.1 **SCREENING AND ELIGIBILITY WILL BE DECIDED ON THE BASIS OF THE DETAILS PROVIDED BY THE CANDIDATE. BEFORE APPLYING FOR THE POST, THE CANDIDATE SHOULD ENSURE THAT HE/SHE FULFILLS THE ELIGIBILITY AND OTHER NORMS MENTIONED IN THE MODALITIES. FURNISHING OF WRONG/FALSE INFORMATION WILL LEAD TO DISQUALIFICATION AND DAV REGIONAL DIRECTORATE WILL NOT BE RESPONSIBLE FOR ANY CONSEQUENCE OF FURNISHING SUCH WRONG/FALSE INFORMATION.**

7.2 The candidates found provisionally eligible for the applied post as per their declaration in the online application shall be called for Computer Based (Online) Test and the provisional Admit cards will be issued accordingly to such applicants.

The DAV Regional Directorate will verify the eligibility at various stages of the recruitment and selection process. The candidate should prove his/her eligibility at all stages of selection process and even after appointment. Mere issue of Admit Card to the candidate will not imply that his/her candidature has been accepted by the DAV Regional Directorate.

No candidate will be allowed to appear in CBT without valid print copy of Admit Card along with valid Photo Identity Card (i.e. Voter ID, Passport, PAN Card, Aadhaar Card, Driving License and Government Identity Card) **in Original** issued by Government of India/ State Government of Odisha Odisha **as well as one self attested copy to be attached with the Admit Card.**

7.3 Candidates already working in other organisation are required to produce "**No Objection Certificate**" from the present employer at the time of document verification/interview. The online test / Computer Based Test (CBT) will comprise of Part-I, II and III. All the questions will be Multiple Choice Questions. The test will be of 120 minutes duration with 80 questions. **Each question will carry 1 mark. There will be negative marking of 0.25 marks for each wrong answer.**

23.1.1 Part-I: General English & Aptitude with 10 Multiple Choice Questions.

23.1.2 Part-II of the test will comprise of 10 Multiple Choice Questions in teaching pedagogy/methodology.

23.1.3 Part-III of the test will comprise of 60 questions on the contents of the specific level and subject.

Finally for preparation of the panel, the following components shall be taken into consideration.

23.1.4 The candidates once placed in merit in the interview, may be asked to give a demo teaching for 20-30 minutes in the concerned subjects as per the mentioned syllabus. The test will comprise of 80 Multiple Choice Questions in General English, Aptitude, Current Affairs, Reasoning and Arithmetic/Accounting etc. Shortlisted candidates of CBT shall have to appear a SKILL TEST on the date of interview.
